I. START OF MEETING/ ROLL CALL

LAMTPO Staff stated that a draft of the FFY2024-2025 UPWP has been done and will send out to the local agencies to just review. It will still need the info from TDOT, but this will be just a heads up to review the document.

VIII. Other Business

Staff gave some background information on the 2020 US Census. Morristown will retain its urbanized area designation. Staff stated that the boundary files had not been released yet, but will keep them updated on the situation.
